## FCDF Stands Up Against Islamic Indoctrination in San Diego Schools

San Diego Unified School District has announced a [partnership](#) with the Council on American-Islamic Relations (CAIR), the nation’s most prominent Islamic advocacy group, to add lessons on Islam in social studies classes as part of an alleged effort to combat anti-Muslim bullying. Unfortunately, that supposed anti-bullying campaign includes many troubling aspects including “[p]rovid[ing] . . . opportunities for staff related to awareness and *advocacy for Muslim culture.*”



FCDF sent a very stern [letter](#) to the Board of the San Diego Unified School District advising them against proceeding with that proposed partnership. FCDF is ready and willing to do everything in its power to fight against advocacy for Islam in our local schools.

## Senate Judiciary Committee Re-refers Planned Parenthood for Prosecution



Earlier this week the Senate Judiciary Committee re-referred Planned Parenthood, StemExpress, ABR, and Novogenix to Attorney General Jeff Sessions for criminal investigation and prosecution.

The [letter](#) sent by the Senate Judiciary Committee states: “Because the referral came during a presidential transition, when Justice Department personnel and enforcement priorities were likely in flux, it is important that the Committee ensure the referral and the report are being given proper consideration.” This is because, as noted in the Senate Judiciary Committee’s report,

*[I]t appears that the Planned Parenthood Federation of America learned that its affiliates engaging in paid fetal tissue programs were not following the policies and procedures it had put in place to ensure compliance with 42 U.S.C. § 289g-2. However, instead of exercising its oversight procedures to bring them into compliance, it contacted the affiliates involved and then altered those oversight procedures in a manner that allowed the affiliates’ conduct to continue. . . . [T]he facts uncovered raise a reasonable suspicion that these organizations, and/or individuals employed by them, may have engaged in a conspiracy to violate the fetal tissue law (18 U.S.C. § 371).*

## Planned Parenthood “Lamborghini” Exec Haggles Again Over Baby Parts Prices In New CMP Video



CMP investigators approached Dr. Gatter about their interest in procuring fetal tissue. During the conversation, Dr. Gatter advises, “You know, you have to pay a little money to use the space.” After asking for a ballpark figure, the CMP investigator observes, “Most people now seem to be doing per specimen.” “Per specimen. Like \$75 a specimen?” Dr. Gatter replies. After the buyer asks for clarification, Dr. Gatter repeats, “\$75 a specimen, or \$50 a specimen?” The buyer replies, “What we’ve been quoting is \$50 per specimen. I think some people are doing more, some slightly less.” Dr. Gatter then comments, **“Yeah, \$50’s on the low end, \$50 was like 12 years ago.”**

## FCDF Takes First Step In Trip to the Supreme Court in NAF v. CMP

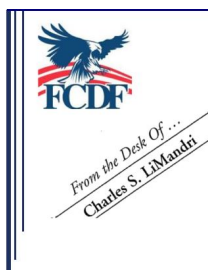
Last time we let you know that the Ninth Circuit upheld an unconstitutional gag order preventing David Daleiden from releasing videos he took at National Abortion Federation Conferences because of attendance agreements he signed. We were surprised by the ruling because the case law is so squarely on David’s side – outside the context of trade secrets and classified information, no federal court has ever upheld a gag order suppressing information of public interest based solely on contracts signed by the parties. This ruling represents new law that the Ninth Circuit has just invented.

Yesterday we took the first step in petitioning for review in the Supreme Court. We filed a [petition](#) to have the case re-heard, not before three judges of the Ninth Circuit, but by the entire Ninth Circuit. If you want to know exactly what was wrong with the Ninth Circuit ruling, that petition lays it all out. Other organizations have also filed [amicus curiae](#) briefs to explain how dangerous the Ninth Circuit’s decision really is for freedom of speech.
